### **GREATEST STUPIDITIES AND DELAYS OF HUMAN PROGRESS**

#### **Part I: USA and the world**

In the framework of the crossbreeding or any other crossing over, the expressed character (or phenotype) is the combination of genes resulting from the genetic inheritance of the two parents (**B**= Black and **W**= White) whatever the type of recombinations of the alleles (Male (**W<sub>y</sub>**) - Female (**W<sub>x</sub>**) / Male (**B<sub>y</sub>**) - Female (**B<sub>x</sub>**)). It results from the above that, one of the greatest human stupidities is racial classification according to the phenotype color.
